Assumption or Risk and Covenant to Indemnify

I (or my child), the undersigned, hereby acknowledge and state that I know and am aware that all horses, whether privately boarded or used for riding instruction, may vary in spirit, are subject to being startled, frightened, nervous reactions, and loss of control which may result in a horse throwing its rider, falling, slipping, jumping, kicking, and jostling riders, other horses with or without riders, or other like conduct, and persons on or about the stables and riding areas of the property known as “Hidden Valley Equestrian Center, Inc.”, where some horses are privately boarded and some are used to teach horsemanship to persons with varying amounts of experience; and that horses because of their weight, strength, weakness’ and natural functions may create conditions in and on the stable, riding areas, and adjacent premises which are dangerous to persons thereon; and I hereby assume the risk of injury and damage there from as well as from all other conditions attendant thereupon, as a condition to admission to the said course, said premises, and the use of horses in connection therewith or apart there from.

I (or my child), the undersigned, do hereby further agree to indemnify and hold “Hidden Valley Equestrian Center Inc.”, it’s instructors, agents, and servants, harmless from any and all claims on account of negligence or breach of contractor warranty in any form whatsoever. Damage to property sustained or suffered by me, my personal representatives or derivative claimants resulting from my (or my child) riding or attempting to ride horses and also any claims arising out of my presence upon the “Hidden Valley Equestrian Center, Inc.”, resulting from my admission into the riding stable, riding areas, and from riding any horses furnished by me or to me in connection with the said course, except if the damages are caused by the direct, willful and wanton negligence of the management.
